Aware of the penalties provided for by art. 76 of the presidential Decree 445/2000, for the hypotheses of false declarations, under one's own responsibility,

DECLARE

- a) Be aware that if you have symptoms of a respiratory infection or a body temperature > 37,5°, cough, difficulty breathing and flu-like / comparable to COVID-19 / pneumonia symptoms, there is an obligation to stay at home.
- b) Not to come from endangered areas in the 14 days before the race day and to have had no contact with persons who were tested positive for COVID-19;
- c) To be aware that it is forbidden for users to enter or stay in the racetrack and technical rooms and is obliged to immediately discriminate against those responsible for the racecourse, even if dangerous conditions exist after entering (flu-like symptoms, fever, etc) and the regulations of the authority require that the family doctor and the health authority are informed and stay at home.
- d) I am informed that i cannot enter the racetrack for today's race day if one of the above conditions occurs;

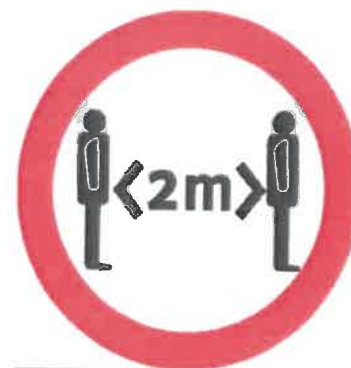
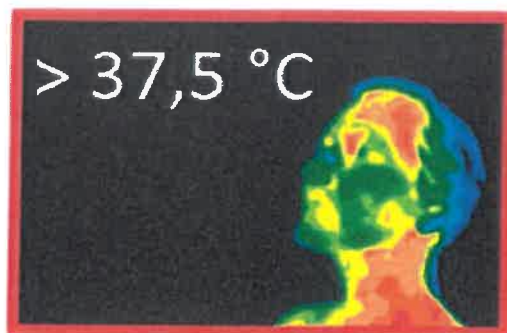

ACCESS RULES

To combat and curb the spread of the Covid19 virus In the workplace

We inform all employees and anyone who has access to the Merano racetrack that the following provisions must be strictly observed:

Obligation for all people to cover their nose and mouth with protective masks at every access.

Obligation to stay at home with fever (over 37,5°C) or other flu symptoms and to contact your own family doctor and the health authority.

Knowledge and approval of the fact that there is no right of access to the racecourse facilities and that it must be reported immediately if, even after access, there are risk factors (flu symptoms, fever, origin from risk areas or contact with virus-positive people in the last 14 days etc) who, in accordance with the measures taken by the authorities, are obliged to inform the family doctor and the health authority and to stay at home.

The obligation to comply with all regulations of the authorities and the company when entering the racetrack (in particular compliance with the safety distance, compliance with hygiene regulations, frequent hand washing, wearing protective masks, especially where the safety distance of 2m cannot be maintained, etc).

The obligation to inform the employer immediately and responsibly about the occurrence of flu symptoms during working hours and to ensure that there is a reasonable distance from the people present.
